Department of Pharmacy Services

- Provides pharmaceutical care 24 hours/day
- 16 Pharmacist, 4 Resident, 16 Pharmacy Technician and 1 Administrative FTE's
 - 11 Pharmacists are Board Certified
 - 7 Pharmacists completed PGY1
 - 1 Pharmacist completed PGY2
- Clinical pharmacists are decentralized, utilizing a unit-based practice model covering several patient care areas and are responsible for the pharmaceutical care of those patients.
- Pharmacists manage the Antibiotic Pharmacokinetic Service, Anticoagulation & Dysglycemia Management Protocols and provide Adult Vaccination Programs for Hospitalized and Ambulatory patients.
- Provides pharmacy student Pharmacy Practice Experience (IPPE and APPE) rotations for several colleges of pharmacy.

Patient Care Service

- Service commitment to provide essential services to patients, to ensure the resident will be able to work independently as a pharmacist upon completion of the residency program and to expose the resident to all pharmacy related technology; to all distribution aspects of medication preparation and delivery; to function in an IV room in compliance of all Ch. 797 standards; to dose, monitor and manage pharmacy protocols; to gain confidence in communicating successfully with physicians, nurses and other practitioners; and to interact with patients in a timely manner.
 - Staff every other weekend and get one comp day mid-week
 - Staff one evening shift per week

Learning Experiences

 Round with team, coordinate with preceptor and attend meetings during the daytime shift.
Projects and research are to be done when time allows during the day or after the daily patient care activities have been completed.

Pharmacy Services

- Resident must be a graduate of an ACPE accredited Doctor of Pharmacy degree program
- Residents must be licensed or be eligible for licensure in IL
- Residents shall participate in and obey the rules of the Residency Matching Program
